- To participate in investigation of all fatal and other incidents.
- To investigate the cases of occupational diseases contracted and reportable dangerous occurrences.
- To advice on the maintenance of such records as are necessary with regard to accidents, dangerous occurrences and occupational diseases.
- To promote the working of safety committees and to act as an advisor to such committees.
- To organize, in association with concerned departments, campaigns, competitions, contests and other activities which will develop and maintain the interest of building workers in establishing and maintaining safe conditions of work and procedures.
- To identify training needs of workers and staff members and make a detailed training calendar for the year and conduct the trainings.
- To assist in preparation of Emergency Response Plan and supervise Mock Drills.
- To frame and establish safety rules and safe working practices in consultation with Senior Officials of the Company.
- Assist in effective implementation of ISO 45001:2018 and ISO 14001:2015.
- To close the non-compliances issued during internal or external audits and ensure they do not reoccur.
- To ensure documentation as per the standard procedures is maintained and recorded.

- To submit collated monthly EHS performance data to the Head EHS, every month.
- To ensure sufficient inventory of PPE and Safety nets is maintained, along with other critical items.
- To co-ordinate with visiting Doctor for regular health check-up of workers.
- To establish tie ups with Hospitals and Authorized vendors for disposal of hazardous wastes.
